Central Falls Police conduct three separate court authorized search warrants where three males and one female were targets of the investigation:

Central Falls – On 2/11/15 Members of the Central Falls Police Detective Bureau in conjunction with the Special Investigations Unit, the Central Falls K-9 Unit and the North Smithfield K-9 Unit executed three court authorized search warrants; these investigations were conducted as a result of numerous complaints from neighbors and information obtained from confidential sources.

Two teams of Detectives executed simultaneous search warrants on 61 Washington Street first floor and third floor. Upon entry multiple subjects were detained and systematic searches were conducted. As a result of the search warrants at these locations in excess of \$20,000.00 in United States Currency was seized along multiple ounces of Heroin and Cocaine. Detectives also seized a Jimenez Arms 9mm handgun with Altered Identification Marks. Detectives then executed a third search warrant at 33 Richardson Street third floor. As a result of this search warrant a large amount of cocaine was seized along with a stolen Taurus 9mm handgun from the State of Kentucky. The following four subjects were arrested for multiple Narcotic Violations and Firearm Violations.

Miguel Colon (28) of Central Falls

- Possession of Heroin in Excess of One Ounce with Intent to Deliver
- Possession of Cocaine in Excess of One Ounce with Intent to Deliver
- Controlled Substance Conspiracy
- Distribution of a Controlled Substance within a School Zone
- Possession of a Firearm while in Commission of a Controlled Substance Violation 2 Counts
- Alteration of Marks of Identification of a Firearm
- Possession of a Stolen Firearm
- Possession of Schedule III Narcotic

Annie Ortiz (35) of Central Falls

- Possession of Heroin in Excess of One Ounce with Intent to Deliver
- Possession of Cocaine in Excess of One Ounce with Intent to Deliver
- Controlled Substance Conspiracy
- Distribution of a Controlled Substance within a School Zone
- Possession of a Firearm while in Commission of a Controlled Substance Violation
- Possession of a Stolen Firearm

All four subjects were arraigned in 6th District Court Providence and were held pending a future Bail Hearing.
